MINUTES FROM AUGUST 8, 2011 WERE READ AND CORRECTED. BRETT SHOULD HAVE BEEN LISTED AS ABSENT AND THE WORD "ADOPTED" SPELLED CORRECTLY. MOTION TO ACCEPT CORRECTED MINUTES WAS MADE BY SUE AND SECONDED BY FRAN.

WORKSHOPS: WAYNE COUNTY PLANNING BOARD IS OFFERING TWO FALL WORKSHOPS ON SEPTEMBER 12TH AND OCTOBER 18TH, 2011. GENESEE / FINGER LAKES REGIONAL PLANNING COUNCIL IS OFFERING TWO WORKSHOPS SEPTEMBER 23RD AND 24TH AND NOVEMBER 17TH, 2011.

COMPREHENSIVE PLAN: TOM LEAD THE DISCUSSION ON UPDATING AND REVISING THE PLAN. - WE FINISHED CHAPTER 2 DISCUSSING 2-49 STORM DRAINS UPDATE SINCE 2000 AND 2-51 PARKING SPACES WITHIN THE VILLAGE. CHAPTERS 3 AND 4 WERE BRIEFLY DISCUSSED. - WE DISCUSSED MONIES AVAILABLE FOR NEW SIDEWALKS. ON 5-7, SHARON COMMENTED THAT THE CAPITAL RESERVE FUND CANNOT BE LISTED UNLESS WE HAVE A BALANCED BUDGET.- APPENDIX "A" SHOWS THAT 20% OF THE VILLAGE RESIDENTS RESPONDED TO THE 2000 SURVEY. THERE WAS A DISCUSSION ON DOING A NEW SURVEY TO RESIDENTS AND BUSINESS OWNERS. MEMBERS ARE TO COME UP WITH "10" QUESTIONS FOR THE SURVEY. THERE WAS A DISCUSSION ON HOW TO DISTRIBUTE THEM. - MAPS 2-52 AND 2-53 SHOWING ZONING FOR THE VILLAGE NEED TO BE REASSESSED. DOES THE COUNTY HAVE AN UPDATED VERSION OF TAX PARCELS?
