### **CALL MEETING TO ORDER:**

Meeting was called to order at 6:00 pm. Mayor Letson led the meeting in the Pledge of Allegiance.

# STEVENSON DRIVE DOG KENNEL ISSUE:

The board received the petition from the residents on Stevenson Drive at the last meeting. There will be no decision made on the plan until the Village receives paperwork from the property owner with site plans.

## **SEWER GRANT:**

Mayor Letson informed the board that the project cost has significantly increased, therefore we will not be taking on that project. We will get the project reengineered hoping for a lower price.

# **SPEED RADAR SIGNS:**

Mayor Letson presented the board with 3 different companies that provide radar signs. The Village is looking to purchase 5 signs. After talking with surrounding areas that have put these sings in, their speed has dropped 25-30%. During the discussion Trustee Bettis challenged the mayor's right to vote.

Radar Signs- The total cost for 5 signs is \$18,230, 15% of that would be covered by CHIPS money. \$15,495 would be taken out of the CHIPS money, the Village would be responsible for \$2,734.50 which is \$546.90 each sign. Company will come out and do all the set up, they would be running by the time they are done. The Village can not ticket anyone from the signs.

A motion was made by Mayor Letson, seconded by Trustee Letson to purchase the signs. Roll call vote as follows: Trustee Bettis, nay;Trustee Huntington, nay; TrusteeLetson, aye; Mayor Letson, aye. Motion did not pass.

#### SURVEY VILLAGE PROPERTY:

Mayor Letson would like to get a quote from Mr.Getman on survery for the properties around the wells and Maurice LaFave property. The board all agreed it is ok to get a quote.

#### SPOT PAVING:

There are three spots that need to be paved- in front of the ABC Daycare, Charlan Allen's house and Parmeter water turn off. Mayor Letson would like to contact Home state Paving for price. Trustee Huntington will get the information from a company from Wolcott.

# **CHIPS FUNDING:**

The Village would like to use CHIPS funding for paving South Street. Before paving can start there needs to be new water services put into 16 locations. Wayne County Water and Sewer Authority will get a price for the water services.

# **PITSTOP WATER REPAIR:**

The Village will have an exploratory dig on June 29<sup>th</sup>, the main repair will be done between July 6<sup>th</sup>-8<sup>th</sup> 2021.

### JAY GUNNER APARTMENTS:

Mayor Letson informed the board that there was a tenant parking on the sidewalk and would not move their vehicle. Jay Gunner is concerned there isn't enough space for all of his tenants to safely and legally park. Does the Village want to leave the situation as it is, assign parking spots or let property owner figure it out? The board feels this is the property owners responsibility.

# **NO SWIMMING SIGNS:**

There will be NO SWIMMING signs put up around the pond.

### **CAMERAS DOWNTOWN:**

Mayor Letson would like for there ti be a camera placed near the bridge. It must be a Village phone number associated with the camera. A tech will come out and sure everything is working. The price is \$159.99 per camera. A motion was made by Trustee Huntington, seconded by Trustee Bettis. Roll call vote as follows. Trustee Bettis, aye; Trustee Letson, aye; Mayor Letson, aye; Trustee Huntington, aye.

### LAWYER:

Mayor Letson talked with the lawyer about the marijuana law, she said we should opt out and wait to see how surrounding areas do with it before we take it on. The law is not for local growers and smokers. A motion was made by Mayor Letson to opt out of the Marijuana Law, seconded by TruteeLetson. Roll call vote as follows. Trustee Bettis, aye; Trustee Letson, aye; Mayor Letson, aye; Trustee Huntington, aye.

### DEC:

Mayor Letson informed the board that the DEC is against open burning in Villages, there should be nothing over 3 feet, and needs to be fully extinguished when the burn is over. Does the Village want to adopt a local law regarding burn pits? The Board will think about this and revisit the next meeting.

### **PUBLIC FORUM:**

Art Riggs proposed a drawing of a plan he would like to do concerning the draining in front of his house. He would like to put berms on sidewalk, take out one of the sidewalk blocks at his own response. Art Riggs will talk to Trustee Huntington and Trustee Bettis about options.

### **EXECUTIVE SESSION:**
