Mayor Henner called the meeting to order at 7:00 pm with the Pledge of Allegiance.

8031 East Port Bay Road owner forwarded an email to Deputy Clerk-Treasurer Toni Kellam that was previously sent to the former Deputy Clerk Treasurer on May 18, 2021 but was never responded to. This is in regards to a water service the owner thought was previously abandoned by the former owner, yet he was still getting billed for the tap. Ed Wazinski will contact both the current and previous owner to try and resolve.

Fire Department-Chief Jerry Lasher

The annual 2024 fire protection contracts have been signed by Mayor Henner and Fire Chief Lasher and will be mailed to the Towns of Huron, Butler and Wolcott.

Police Department-OIC Brian Ritchie

OIC Ritchie will continue to follow up with Newark Police Chief regarding reimbursement of the ballistics vest for Eric Minisce. Newark Police Chief sent grant reimbursement information to Clerk-Treasurer Acker. Further action by the board has been tabled until OIC Ritchie is able to follow up with the Newark Police Chief.

Mr. Mettler stated all is running well.

Tommy Mettler made the Village Board aware that a new block heater is needed for the Jefferson Street Pump Station.

Mr. Mettler made mention of high flows at the East Port Bay Road on January 9, 2024 that came from Twisted Creek Campground. The campground will be billed for the extra water.

Water Department-Ed Wazinski

Sheryl Robbins from the NYS Department of Health will be on site this week to perform Garth Moody's assessment do move forward with his NYS water license.

Mr. Wazinski said he has started working with the entire Water Department on the shut off list.

Outside village residents are responsible for payment of replacing water meters. Mr. Wazinski explains this to the property owner before meters are replaced. Once replaced and billed, complaints have been received by Village personnel. Trustee Lewis made the motion to accept and approve the "Outside Water Customers Meter Payment agreement" to be signed by the property owner that they acknowledge they are responsible for payment and the breakdown of payments. Trustee Marshall 2nd the motion. All present voted in favor.

The current water shut off list was provided to the board.

Village Clerk-Treasurer

An updated emergency response plan was submitted to the board to review and approve. This was tabled so the Fire Department and the school can be consulted and the plan edited towards the Fire Department.

Each department head received their wish list template for the upcoming 24-25 budget workshop. Tommy Mettler will try to set up a meeting with Todd at Evoqua.

Trustee Lewis made the motion to prepay Laberge Group invoice 202314800001 in the amount of \$6,500.00 for professional services related to the Wolcott Interim Dissolution study. The LaBerge Group submitted application for a reimbursement grant to help cover some of the cost for the study. Trustee Marshall 2nd the motion. All present voted in favor.

WHEREAS, the Village of Wolcott Dissolution Election will be held on Tuesday March 12, 2024 from 9:00am-9:00pm and the General Election will be held on Tuesday, March 19, 2024, from 12:00pm-9:00pm with voting by paper ballot at the Wolcott Village Hall, located at 6015 New Hartford Street, Wolcott, NY 14590.

BE IT RESOLVED that with registration day abolished, only those residents of the Village of Wolcott that are registered with the Wayne County Board of Election will be eligible to vote in both the Village of Wolcott Dissolution Election on March 12, 2024 and the Village of Wolcott General Election on March 19, 2024.

ALSO, BE IT RESOLVED that in conformance with the New York State Election Law, Section 15-104, Subdivision A, the Village of Wolcott Board at the January 23, 2024 meeting designated the following offices and terms to be filled at the Village of Wolcott General Election to be held Tuesday, March 19, 2024:

Trustee (2)	Four Year Term

ALSO WHEREAS, the Village of Wolcott Board will appoint 2 Election Inspectors and 1 Alternate, and it is the duty of the inspectors of the election to prepare such register of qualified voters for this district for which they are appointed.

ALSO, BE IT RESOLVED:

- 1. No person shall be eligible to vote in the Village of Wolcott General Election unless that person is registered with the Wayne County Board of Elections.
- 2. Voting for the forthcoming election shall be conducted by paper ballot at the Wolcott Village Hall, 6015 New Hartford Street, Wolcott, New York from 9:00 AM 9:00 PM on March 12, 2024 for the Village Dissolution and 12 Noon to 9:00 PM on Tuesday, March 21, 2023 for the General Election.
- 3. The notice of the dissolution referendum will be published in the Times of Wayne County and the Lakeshore Newspaper at least once a week for four consecutive weeks immediately prior to the referendum. The notice will include:
 - A summary of the resolution's contents and the petition for dissolution;
 - A statement as to where a copy of the resolution and petition can be examined;
 - The name of the village to be dissolved and a description of its territories;
 - The time and place at which the referendum will be held; and
 - Such other necessary matters to call, provide for and give notice of the referendum and

to provide for the conducting and canvassing of the referendum

- 4. At least 20 days prior to the General Election Day set forth in this Resolution a copy shall be posted in at least six conspicuous public places in such Election District and published in the Official Newspaper.
- 5. The Inspectors of Election shall be: Jean I. Short and Lorelei A. Howland at the rate of \$23.63/hour for each election. The alternate will be Phillip Juliano.
