I agree to complete all preparations for my exhibit by 11:00am, August 6. Set up time is 7:00am – 10:00am. I agree to keep the space occupied with goods on display until 8:00pm, closing time for the event. I will be provided with water and 4 bags of complimentary ice.

I agree to be solely responsible for my agreement and for all acts of my agents and employees. I will issue sales receipts for all purchases and will fully guarantee all merchandise to be as described. I agree to collect and pay sales tax as provided by law. The Wolcott Chamber of Commerce and the Wolcott Lions Club shall have full right to make and interpret such rules and regulations for the show as it deems proper and necessary, and I agree to comply with such rules and regulations.
