**AWARDING CONTRACT BID FOR CONTRACT NO.2: FORCE MAIN**

**Introduced by Trustee Buckalew:**

**WHEREAS**, on March 12, 2013 a Wolcott Village Board Meeting was held at the Wolcott Village Hall

**WHEREAS**, the low bidder for Base Bids A and B, 8-inch and 10-inch force mains, respectively was F. Rizzo Construction, Inc. The bid for the 8-inch option was \$893,757.00. To accommodate additional flows from the Port Bay area in the Town of Wolcott, the Wayne County Water & Sewer Authority (WCWSA) has agreed to pay the additional amount of \$144,420.00, for the 10-inch option cost of \$1,038,177.00.

**WHEREAS**, after review of the bids submitted, a motion was made and seconded to award the contracted bid to F. Rizzo Construction, Inc. for the bid amount of \$1,038,177.00.

**THEREFORE BE IT RESOLVED THAT** the Village of Wolcott Board of Trustees hereby approve the Motion of March 12, 2013 to award the contract bid to F. Rizzo Construction, Inc. for the bid amount of \$1,038,177; and be it
