Mayor Baker opened the meeting at 7:02 PM.

Pledge of Allegiance

Highway Department

There was discussion about the purchase of a new pay loader. CASE, CAT and JCB all have comparable machines with fixed pinned buckets. Neither of these machines have a set of forks however, they can be purchased separately or take the cheaper route and purchase a set of forks for the skidsteer. CAT does offer a buy back program. After purchasing the pay loader it would be an annual cost of \$10.00 per clock hour and any price increase for a new pay loader. CAT has offered \$20,000 for the Samsung pay loader on trade. A decision needs to be made relatively fast as there is a 3-4 month lead time. CAT also offers a 1 year bumper to bumper warranty. Clerk-Treasurer Lori Tyler gave different financial options that she will look into.

The decision was made to list the 2005 John Deer tractor in the County auction flyer.

Surplus Equipment

Trustee Penta made the motion to declare two "Men at Work" signs as surplus. Trustee Buckalew seconded the motion. All voted in favor.

Trustee Graham made the motion to declare a Wheeller model 6H pipe cutter as surplus.

Trustee Skinner seconded the motion. All voted in favor.

Trustee Penta made the motion to declare a Marlow ITT mud sucker 8 horse power pump as surplus. Trustee Skinner seconded the motion. All voted in favor.

Trustee Skinner made the motion to declare a BH&E 8 horse power 3 inch trash pump as surplus. Trustee Graham seconded the motion. All voted in favor.

Trustee Penta made the motion to declare a Mueller ³/₄-1 inch tap machine as surplus.

Trustee Buckalew seconded the motion. All voted in favor.

Timothy Jones

Highway Foreman Nick Rizzo stated that Tim Jones is still in the hospital. Clerk-Treasurer Lori Tyler stated that she would need a work release from his Doctor upon his return to work.

Fire Department

Fire Chief Ray Wellington submitted the 2013-2014 Officers for approval. (See attached sheet for listing)

Trustee Penta made the motion to approve the 2013-2014 Officers. Trustee Buckalew seconded the motion. All voted in favor.

Fire Chief Ray Wellington submitted three (3) quotes from Geneva Glass, Wolcott Glass and Flower City Glass to remove and install five (5) new pass doors at the fire hall. Trustee Penta made the motion to approve the quote from Wolcott Glass in an amount not to exceed \$8,000 for the removal and installation of new doors. Trustee Buckalew seconded the motion. All voted in favor.

Fire Chief Ray Wellington submitted three (3) quotes from Monroe Insulation, Betlem Heating and Cooling, and Brisky Supply (material only) for insulation to be installed in the attic of the fire hall. Trustee Graham made the motion to approve the quote from Betlem Heating and Cooling in the amount of \$3,200. Trustee Buckalew seconded the motion. All voted in favor.

Fire Chief Wellington obtained quotes to have the lighting updated to be more energy efficient at the fire hall. Trustee Penta made the motion to approve Mike Cornelius to replace the light fixtures in the amount of \$2,330, contingent on Mr. Cornelius having proper insurance. If Mr. Cornelius is to be found deficient, then Jakaris Tool shall perform the work in the amount of \$3,414 after the \$600 NYSERDA rebate. Trustee Graham seconded the motion. All voted in favor.

Fire Hydrants

The Village of Sodus Point is selling used fire hydrants that are in good working condition. Fire hydrants with guard valves are \$1,000 each and with out guard valves are \$800 each. Trustee Skinner would like to see the work on fire hydrants documented on maps. Trustee Graham made the motion to purchase two (2) fire hydrants with guard valves in the amount of \$2,000. Trustee Buckalew seconded the motion. All voted in favor.

The bolts need to be replaced on the overlook at the Wolcott Falls Park per Code Enforcement Officer Otis Vezzose. Trustee Skinner made the motion to approve the quote in the amount of \$350.00 for Harter Construction to replace the bolts. Trustee Buckalew seconded the motion. All voted in favor.

Corinne Mott

Clerk-Treasurer Lori Tyler asked the board for an additional 40 hours of assistance from Corinne Mott. These hours will be used to assist Deputy Clerk-Treasurer Brett Norsworthy as well as the closing of the 2012-13 fiscal year. Trustee Penta made the motion to approve the hours for Ms. Mott. Trustee Buckalew seconded the motion. Mayor Baker called for a vote.

In the past when prepared food was brought into the Village to sell, the vendor was required to obtain a Solicitors Permit.
