**CALL MEETING TO ORDER:**

Meeting was called to order at 9:45 am.

There was discussion regarding a tire that needs to be replaced. The cost for the tire replacement is \$270.04. Maps will be available after this weekend.

**SNOW REMOVAL:**

Roll call vote as follows: Mayor Letson, aye; Trustee Letson, aye; Trustee Schiller aye. The snow blower will be stored at the Letson house to be able to do South Street early for school.

## **SNOW MOBILE/ ATV LAW**

There was discussion regarding Local Law # 1 of 2018 - Regulating ATV and Snowmobiles in the Village of Red Creek. The board would like to change Section #6 - Operation On Corporate Limits - No snowmobile or ATV shall be operated within the corporate limits of the Village of Red Creek between the hours of 2:00 am and 6:00am am. The new wording will read: between the hours of 10:00 pm and 6:00 am. The local law states that the following individuals are authorized to issue appearance tickets: State Police Officer, County Sherriff, Village Mayor or Trustee, Village Safety Officer, Conservation Officer, Parks and Recreation Officer, or by any other law enforcement officer or other person so designated by the Village Board of Red Creek. The Code Enforcement Officer has appearance tickets available to use. When issuing an appearance ticket, an accusatory statement also has to be completed.

The mayor will contact the attorney to have the above change made and the Village will hold a public hearing regarding this local law on February 14, 2018 at 6:30 pm.

The mayor has contacted the person in charge of the apartment building on Main Street. She has discussed parking, plowing and ice on the sidewalk.
