# **CALL MEETING TO ORDER:**

#### ABSTRACT:

At this time the clerk presented the board with Abstract # 012. There was discussion regarding the tamper rental and a bill from Reeds for repairs to BR-40. Bartlett Well Drilling is pulling the well head this afternoon for the well head repair. They will also be working tomorrow.

There was discussion regarding a part time office person. The budget will have to be amended to account for the employee. The job would be for 15 hours per week at \$13 per hour. The total for the year would be \$10140. A motion was made by Trustee Bettis, seconded by Trustee Schiller to give the mayor permission to put the notice in the paper. Roll call vote as follows: Mayor Letson, aye; Trustee Huntington, aye; Trustee Letson, aye, Trustee Schiller, aye, Trustee Bettis, aye.

The mayor has called LaBella regarding the Hawley Road bridge. The mayor met with Chris Beyer and Trustee Schiller to look at the bridge for possible grant money. The village must spend the money and then be reimbursed. There is a 5% match that the village would be responsible for. The village would have to bond for the total amount and then pay it off when the funds are released.

The mayor has spoken with Brian Younglove regarding paving by the bride on South Street. The village also needs to finish the sidewalk on South Street as well.

# **NEW BUSINESS:**

There was a discussion regarding the code enforcement officer not being at meetings. There was a letter sent out to a landlord regarding the Landlord/Tenant Law. There was no application in the violation and no way to remedy the violation. The code officer has already done a walkthrough of the property.

Trustee Huntington asked how many people are working at the village for DPW. We currently have one full time, one part time (24 hours a week) and an on call person.
