## **CALL MEETING TO ORDER:**

Meeting was called to order at 6:30 pm. Mayor Letson led the meeting in the Pledge of Allegiance.

### **PUBLIC FORUM:**

Dale Roberts from Wolcott Street expressed his concerns with the new snowmobile law. He was wondering about the route of snowmobiles to the trail. He was concerned that he cannot drive his snowmobile from his house to the trail. He doesn't think it's right to regulate residents and make it difficult to get to the trail.

Kevin and Dawn Parmeter were into discuss drainage problems at their house. During rainstorms, the water runs down Exchange Street and right onto their property. He brought video to show the board the water running as well as a potential break in the drain about 40 foot from the neighbors house. The mayor stated that the board would look into the problem and get back with him. Kevin would like the drainage issue repaired before he hooks his sewer up.

A house on Main Street would like a permit to install an outside entrance to the upstairs apartment. The code enforcement officer will need to check with the county to see how they have the property listed whether it is a one family or two family. The owners will speak with the code enforcement officer about this.

### **MAYORS REPORT:**

The mayor provided the board with an estimate for paving repairs in the village. The asphalt plant will be shutting down soon so a decision needs to be made. A motion was made by Trustee Huntington, seconded by Trustee Schiller to accept the estimate for paving repairs in the amount of \$2116. The sewer connection update is as follows: the third letter has gone out and by December 1, 2018 the following must be done: Application, Fee paid, and plan of attack.

The mayor has provided the board with two employment applications. One for part time winter DPW and one for cleaning. The board would like to see the part time winter position advertised as we do not have any other applications that may work. The board would like to see if someone in the village would be interested. The part time seasonal worker would be 2-3 days per week and on call during a snowfall. The board would also like an ad for the cleaning position.

#### **CLERK REPORT:**

The clerk presented the board with a quote from Eastern Shore Associates for the mandatory Fire fighter cancer insurance. The cost would be \$137 per active interior fire fighter. The village currently has 11 active fire fighters who would qualify for the insurance.

The clerk has a quote from Seth Galek, Wayne County Water and Sewer Authority for reagents for the chlorine analyzers. The quote is in the amount of \$532. A motion was made by Trustee Huntington, seconded by Trustee Schiller to allow Seth to purchase the items needed.
