Mayor Baker called the meeting to order at 7:00 pm.

Pledge of Allegiance

Fire Department

- Annual inspection for ladders and Quint has been completed
- Battery, switch and hydraulic hoses have been replaced on Quint 4
- Monitor on Quint 4 was not working
 - o Had it sent in to be checked out
 - o It is a 1992 model that cannot be repaired
 - o Chief Wellington is currently looking for replacement models
 - o Expected replacement cost is about \$5,000
- Air Packs have been inspected
- E34 went in for brake adjustments
- The enclosed trailer is being customized
 - o Racks and storage are being installed inside
 - o Lettering has been done
 - It is looking good
- The lettering on the Fire Department doors is done and really looks good
- Chief Wellington was attending a Truck Replacement Committee meeting this night
 - One thought they are considering is to sell E32 and E34 and replace them with one new truck

Police Department

- January so far has been a quiet month probably because of the cold
- OIC Tom Ryan asked about progression of the General Orders
 - Brian Rietz and Quint Husted have had copies for review and have not voiced concerns
 - OIC Ryan would like to forward them to Art Williams for review
 - Mayor Baker stated that he would like to meet with all officers and Trustee Buckalew to go over the General Orders prior to releasing them to Art Williams
- There has been some progress in the local break ins
 - A suspect has given up names to the State Troopers to follow up on
- Range time will be coming up soon. Most likely in April
- There will be another Drug Take Back day in April

Highway Department

- Truck 103 is in back in service
- Shut off Holiday lights
- Changed holiday banners back
- Truck 119 Changed oil pan
- Truck 119 & 109 Changed cutting edges
- Pot Holes
- Truck 119 Changed headlights
- Cut trees down around Springs Plant fence
- Changed rubber on snow box
- John Deere 2320 waiting on 1 bearing that is on factory back order
- Working on next year's budget
 - o Mr. Rizzo stated that he is looking into a new snow box
 - o The new pay loader is capable of utilizing a much bigger box
 - This would save time and money for the Village
 - He would also like to get one with a steel cutter plate that flexes
 - This would eliminate the need to change the rubber on the box
 - The rubber at the moment runs just over \$300

Sewer Department

- Blowers were serviced on 12/18/13 by Snyder Technical Services No issues were found
- Pump Stations No change
- Waste Water Project No change since last meeting that Eric presented his update at
- Assisted Highway in plowing from 12/10/13 01/28/14
 - o 60.75 Hours Straight Time
 - o 17.25 Hours Over Time
- Jake helped out in the Water Department a few times
 - o 5 Hours Straight Time
 - o 2.75 Hours Over Time
- Sewer Overtime 3.75 Hours
- Automated Grit Removal for Sewer System
 - o Mr. Mettler would like to have this considered to be put into the project
 - o He believes it would add \$225,000 to the project
 - o He says this would be very beneficial and cost effective especially in the long run
- Road to 89 pump station
 - Mr. Mettler advised the board that the driveway is in poor shape and should be replaced
 - o After talking to Nick Rizzo they believe it would cost about \$40,000
 - Mr. Mettler stated that if he had money left over this year he would like to see it done even if they only get half of it done.
 - o If not this year Mr. Mettler will include it in next year's budget

Water Department

LAKE PLANT

- Fixed the mixer in number 1 clarifier It had a bolt stuck under the bottom works fine now
- Fixed broken block in number 2 filter
- Have not been running Lake Plant much due to Springs influent being so good
 - o Influent is currently about 194 gpm
- Running it once a week mainly to keep it exercised

SPRINGS PLANT

- Need turbidimeter repaired or replaced ASAP
 - Mr Sharpe presented the board with a series of quotes for replacement and upgrade of the turbidimeters as well as service agreements for equipment (including required calibration) both at the Springs Plant and Lake Plant
 - o Trustee Smith made the motion to approve Hach Quote #313018514 in the amount of \$9,729.16 to upgrade the turbidimeters at the spring plants and to enter a service agreement with Hach for equipment at both plants. Trustee Murphy seconded the motion. All voted in favor.
- UV unit has a bad socket/ballast that needs to be replaced
 - o Mr. Sharpe presented a quote from Koester to make the necessary repairs
 - Trustee Smith made the motion to approve the quote form Koester in the amount of \$2057 for repairs to the UV system. Trustee Skinner seconded the motion. All voted in favor.
- Have done a lot of housekeeping and painting at the Springs Plant. It is really looking good

GENERAL SYSTEM

- Ordered new seat for hydrant on West Main St by old Agway building. Will replace ASAP
- There may be an issue with a valve at the cold storage. It is leaking but has slowed down. We may need to dig it and repair it
- Need to order Lead Free Brass. The parts we have now are not allowed for use anymore
 - o Mr. Sharpe presented a quote from Blair for some needed parts
 - o In order to have 2 each of these parts it would cost about \$900
 - Trustee Smith approved the purchase of 2 each of the parts listed
 - Mr. Sharpe is to obtain a purchase order from the Clerk's office
 - Mr. Sharpe also stated that he would check another company to see if they
 had better pricing but historically Blair has provided the better price
- Meters will need to be read soon. Will replace meters that need to be as we find them

Mayor

- Sealed bids for surplus trailers
 - o Bids were opened by Mayor Baker
 - High bid for Rally Sport 7710 in the amount of \$477 was placed by Dennis Hadcock of Red Creek.
 - Trustee Murphy made the motion to accept the bid placed by Dennis Hadcock in the amount of \$477 for the purchase of one (1) Rally Sport 7710 open trailer. Trustee Skinner seconded the motion. All voted in favor.
 - o High bid for the 4' x 8' Open Trailer in the amount of \$187 was also placed by Dennis Hadcock of Red Creek.
 - Trustee Murphy made the motion to accept the bid placed by Dennis Hadcock in the amount of \$187 for the purchase of one (1) 4' x 8' open utility trailer. Trustee Smith seconded the motion. All voted in favor.
- Mayor Baker stated that he had recently spoken to Don Cardinal regarding a new federal
