obtain other quotes. The documents have been sent, and accepted by OCR and the village can now award the Engineering to MRB, and the Grant Administration to LaBella Associates.

Trustee Barnes has obtained an estimate from Weeks Construction to replace a door at the village garage and remove the ramp from the back of the old village hall and replace it with stairs. The amount of the estimate is for \$1685.81. This amount includes the door. A motion was made by Trustee Letson, seconded by Trustee Schiller to accept the proposal as presented.
