SEWER GRANT:

The board would like a time frame for the sewer project for South Street.

OLD BUSINESS:

Private Septic Law: the board would like to merge this with the sewer law. Attorney Palermo stated that the DEC has a model law that the board can take a look at. Attorney Palermo will also put together a law for the board to look at. The clerk will email the landlord tenant law to the attorney for him to check out and we will need a definition of a "temporary guest"

MAYOR REPORT:

The following correspondence was submitted:

- Colacino Industries quote for exhaust fan at the Sterling Station Road Pump House Estimate is for \$3951.26. It was determined that a fan is needed but the board would like additional quotes.
- Colacino Industries quote for chlorine analyzer automatic injector estimate is for \$7947.40
- BMB Hardscapes quote for side walk installation along Main Street from Erika's Salon south towards Fat Frankie's Pizzeria - \$1309.74 for installation and \$1450.00 for concrete. After a discussion regarding the amount in the sidewalk fund (\$1500) it was decided to check to see if we could use CHIPS money for the side walk. There also needs to be a plan in place for budget time when starting projects like this one.

Trustee Bettis left the meeting at 7:22 pm.

CLERK REPORT:

The clerk presented the board with Resolution # 9 of 2016. This resolution is authorizing the village to purchase a 2016 Caterpillar back hoe. A motion was made by Trustee Barnes, seconded by Mayor Palermo. Roll call vote as follows: Mayor Palermo, aye; Trustee Huntington, aye; Trustee Schiller, aye, Trustee Barnes, aye; Trustee Bettis, aye.

The clerk also asked board members if anyone would be able to attend the Village Officials Meeting in Sodus on August 24, 2016. No one will be able to attend.

<u>FIRE COMMISSIONER</u>: Trustee Huntington asked about the meeting between the fire counsel and the village board. It was also discussed that any bills presented for payment without the invoice will not be paid, they will be returned for proper documentation.

WATER COMMISSIONER: Colacino Industries quotes were discussed earlier.

<u>SEWER COMMISSIONER:</u> Sewer law and sewer grant information was discussed earlier.

HIGHWAY/SIDEWALKS COMMISSIONER: Dan Rago has spoken about the drainage downtown.

TREES AND PARKS COMMISSIONER: Trustee Schiller would like to know the scope of the project to know where the rip rap will be placed. Trustee Schiller will get with Steve and Bob regarding the project.

SAFETY AND HEALTH COMMISSIONERS: PESH was in to do an inspection. Violations were noted. The village will be getting a certified letter with the violations noted. Some of the violations were: respirator protection, confined space, training of HAZMAT awareness, work place violence. They also noted that the back hoe chains were not load rated, and we were missing SDS sheets for three chemicals. PESH also needs copies of three years of SH900 forms. The gas cans being used at the village are not PESH certified and it was suggested to purchase a gas pump on a cart for ease of use. The board asked for prices on the pump system.

<u>AGING/YOUTH AND RECREATION COMMISSIONERS:</u> Soccer starts Monday. The current balance in the fund is \$1423.48. This balance is to purchase t-shirts for soccer, ice-cream and to pay the director at the end of the season. At this time, the fund will be short monies. Trustee Barnes has also attended a Medicare seminar which is very helpful in educating people about the choices available.
