Real Lease – Mike Ruocco

Mr. Ruocco was present at Board request to discuss Municipal Lease Agreements through his company Real Lease. Mr. Ruocco discussed the merits of leasing over bonding. He gave a brief overview of the process involved in Municipal Leasing as well as current interest rates and terms available.

John Deere Tractor Repair Quote

The JD 4110 tractor is in need of repairs to the front axle. This tractor is used for mowing lawns and sidewalk snow removal. A quote was received from Lakeland Equipment to repair the tractor in the amount of \$3,965.86. After brief discussion it was decided to try to put the tractor back to together as a 2 wheel drive unit and use it exclusively for mowing. Options for sidewalk snow removal will be looked into.

Facility Use Request

Trustee Smith made a motion to approve the Northup Park Use Request made by Lyons National Bank to hold their annual Easter egg hunt on March 28, 2015. Trustee Buckalew seconded the motion. All voted in favor.

Deputy Clerk Norsworthy

Mr. Norsworthy presented the board with figures regarding chronic past due water/sewer accounts. Most of these accounts are outside the Village and have been shut off for some time. The Board directed Mr. Norsworthy to email Art Williams to determine what can be done with these accounts as well as the private lines (Bird Roads) outside the Village.

Mayor

Nothing at this time.

Trustee Buckalew

Trustee Buckalew informed the Board that Jeff Warick has been helping out with a couple projects including dropping gravel and hauling away snow. At the time of this current abstract, the Village has been billed for \$300.

Trustee Buckalew stated that Nick Rizzo had successfully located a replacement fuel tank for the plow truck and that it should be on the way to the Village.

Trustee Buckalew has asked Nick Rizzo to make snow removal from around fire hydrants a priority.

Trustee Buckalew mentioned that it may be a good idea to begin looking into leasing a second snowblowing rig if we are unable to get both of our current machines back up and running.

Trustee Skinner

Trustee Skinner reminded the Board of his discussion from a previous meeting regarding water & sewer abandonments and charges for abandonments. He questioned if anyone had thought any more on the subject. Mr Skinner would like to re-structure the fees associated with water services, stating that a fee should be involved for abandonments. Mr. Norsworthy was directed by the Board to contact Wayne County Water and Sewer Authority to determine what they do in the event of an abandonment request.

Trustee Smith

Trustee Smith is concerned about making certain the sidewalks are cleared in a timely manner and are safe for the children of the Village to walk to school. Trustee Smith asked the board to consider hiring a seasonal, part-time employee whose sole responsibility would be to clear sidewalks.

Trustee Henner

Trustee Henner inquired about Jeff Warick's invoice for \$900 for the Oswego St water service repair. It was explained that Mr. Warick's help was requested for the dig. Nick Rizzo felt that due to the terrain in the area of the dig that it would be safer if special equipment was brought in for the job.

Casey Gilbert

Mr Gilbert asked on behalf of the Fire Department if the voluntary water use restriction that was issued by the Village had been lifted. The Fire Department would like to cancel the additional mutual aid that is being dispatched on fire calls. Mr. Norsworthy advised him that the restriction was lifted a week prior. After a conversation the he and Chief Roger Henry on February 2nd, regarding the upcoming weather and the chance of another restricted use request, Chief Henry had decided to keep the additional mutual aid request through the weekend.

Norma Stewart

Ms. Stewart informed that board that she has read the property maintenance codes that she was given at a previous meeting. She feels that perhaps a Nuisance Law was not needed for the Village and that the problem may lie with the Village Court not enforcing the current laws. Ms. Stewart suggested that the upcoming special meeting to discuss the proposed Nuisance Law could be cancelled. The Village Board decided that the meeting would still be held as advertised to discuss the proposed Nuisance Law on
