### **Police Department**

# **Highway Department**

Mayor Henner reported that the storm sewer grate behind the post office is getting bad. It bounces and is very loud when a vehicle passes over it. Mr. Rizzo will look into securing it. Trustee Stewart complimented the Highway department for their work on the flower pots and park gardens.

A letter was read from Village resident Lance Purdy regarding a tree in front of his home that he believes is a danger. It was decided to have this tree removed.

### **Sewer Department**

Members of the Board received a letter from Eric Wies regarding his thoughts on the easements needed for the sewer project coming from the bay. Trustee Stewart made the motion to approve Mayor Henner to sign said easements. Trustee Vezzose seconded the motion. All voted in favor.

## Village Clerk

Clerk Tyler informed that Board that Governor Cuomo is requesting that all Village Mayors and Town Supervisors attend scheduled meetings in order to discuss shared services to help lower property taxes. The next meeting is scheduled for July 12<sup>th</sup>. The Village can opt out but this may jeopardize current and future grant funding. Further questions were brought up that Mr. Buckalew will present to Har-Rob and will bring the answers to the next Village Board meeting.

### Mayor Henner

Mayor Henner has finally received a quote from Mac Stringer for painting the exterior of the Village Office in the amount of \$6,700. This quote did not make it in time to be included in the current budget.

Vitale ahould have a quote to us by next week for the New Hartford Street paving project. Clerk Lori Tyler explained that this job will need to follow NYCOM procurement policy. This means an ad must be placed seeking bids from at least three (3) different sources.

Mayor Henner asked for confirmation that Jeff Warrick had not yet completed the vent extension on Furnace Rd and the dryer bed drain projects. These projects are not yet done. Mayor Henner will contact Jeff Warrick regarding this.

#### **Trustee Stewart**

Trustee Stewart spoke with Town Supervisor Chatfield regarding the recent Town cleanup event. Supervisor Chatfield claimed it was a great success. The unwanted electronics will be recycled into various items.

## **Trustee Marshall**

Trustee Marshall inquired about overhead lights in Northup Park. He stated that the Village has received a quote from RGE to install LED lights at a cost of \$1800. Trustee Marshall suggested that we purchase our LED lights and install them ourselves to save money. He will get together with Nick Rizzo to determine proper lights, purchase them and install them.
